Information will be entered on the computer and any error in the debtor's name, social security number, taxpayer ID number, organization information, or the EFS codes entered incorrectly will result in reporting errors.
- SDCL 57A-9-402** requires the social security number for each individual debtor, the debtor's internal revenue service (IRS) employer identification number of each business, corporation, tradename, d/b/a etc., to be listed.
- An additional fee will be charged to all standard forms containing an attachment.
- Submit the completed and properly signed statement to the Central Filing System together with the proper filing fee*. **You must file in the state of formation of an entity, not the state of the location of the asset.** At the time of filing, the filing officer will return the original copy of the financing statement as an acknowledgement which can be used for a termination.

Debtor name: Enter only one Debtor name in item 3, an organization's name (3a) or an individual's name (3b). Enter Debtor's exact full legal name. Don't abbreviate.

Organization Debtor: "Organization" means an entity having a legal identity separate from its owner. A partnership is an organization; a sole proprietorship is not an organization, even if it does business under a trade name. If Debtor is a partnership, enter exact full legal name of partnership; you need not enter names of partners as additional Debtors. If Debtor is a registered organization (e.g., corporation, limited partnership, limited liability company), it is advisable to examine Debtor's current filed charter documents to determine Debtor's correct name, organization type, and jurisdiction of organization.

Individual Debtor: "Individual" means a natural person; this includes a sole proprietorship, whether or not operating under a trade name. Don't use prefixes (Mr., Mrs., Ms.). Use suffix box only for titles of lineage (Jr., Sr., III) and not for other suffixes or titles (e.g., M.D.). Use married woman's personal name (Mary Smith, not Mrs. John Smith). Enter individual Debtor's family name (surname) in Last Name box, first given name in First Name box, and all additional given names in Middle Name box.

For both **organization and individual Debtors:** Don't use Debtor's trade name, DBA, AKA, FKA, Division name, etc. in place of or combined with Debtor's legal name; you may add such other names as additional Debtors if you wish (but this is neither required nor recommended).

"Additional information re organization Debtor" is always required. Type of organization and jurisdiction of organization as well as Debtor's exact legal name can be determined from Debtor's current filed charter document. Organizational ID #, if any, is assigned by the agency where the charter document was filed; this is different from tax ID #; this should be entered preceded by the 2-character U.S. Postal identification of state of organization if one of the United States (e.g., CA12345, for a California corporation whose organizational ID # is 12345); if agency does not assign organizational ID #, check box in item 3g indicating "none."

If "year" and "quantity" are left blank, perfection continues for all crops for every year the statement is effective, and for all crop years during the effective period of the statement.

QUANTITY: Number of bushels, head of livestock, or other commonly used identifier. Specify the units.
